

Holy Redeemer School Tax Credit Scholarship (SGO)

Below you will find the information regarding the Tax Credit Scholarship (SGO) from the Institute for Quality Education and for the 2022-2023 school year. Included with the information, you will find basic information regarding eligibility and the application process for the scholarship. At this time, you may begin to complete the necessary paperwork and return it to the school office. We ask that all required documentation and applications are completed and turned in no later than Friday, April 1, 2023. Tax Credit Scholarship (SGO) The Tax Credit Scholarship (SGO) from the Institute for Quality Education (KG-8) is a \$500 minimum award from Educational CHOICE Charitable Trust. The legislation allows for all current Holy Redeemer students, new and eligible incoming students, including kindergarten, to apply. This is a “stepping stone pathway” scholarship for students to become eligible for the School Choice Scholarship if financial requirements are met for the School Choice Scholarship the following year. All SGO scholarship money is donated by Holy Redeemer Parishioners and the Knights of Columbus. The Tax Credit Scholarship is limited and will be awarded based only on availability of funds. Families are encouraged to consider making a donation to the SGO. That donation will result in a 50% tax credit for the donor and will support the growth of Holy Redeemer School. Donations can be made in any amount.

To apply for the Tax Credit Scholarship (SGO), please follow the steps below:

1. Verify that your family meets the Income Eligibility Guidelines listed above.
2. Complete the Tax Credit Scholarship Application (SGO), one per child (Back Page)
3. Attach a copy of your signed 2021 Federal 1040 Tax Return. Married couples filing separately must submit both 1040 forms. We need the two pages documenting lines 1-24.
4. Return completed application form(s) and Tax documentation to the school office attention to Mrs. Dickel.
